- Breakfast Program lots of kids using it, has been framed to the kids as "if you need food or more food, come and get it". A real positive for the kids. approximately 50 kids a day so far.

# **Stipend for Teachers per student**

- Want to offer money to teachers to put towards extra actives for the students through out the year.
- We have about \$40,000 in the back, ran numbers based on \$35,000 to give a buffer. Contingent on getting a \$26,000 grant for the Pour N Play for the playground.
- Can comfortably give \$40 per student to the school, which is \$32,000 total
- Parent Council will give money as a whole to the school, who will then track receipts and spending of money by teachers. Parent Council will need the first \$1000 documented field trip for gaming. School will control, so Parent Council won't need to motion for each individual use of money. Money is be used to enhance the students learning in some way not just for pizza parties and such.
- Motion by Stephanie for Parent Council and Community Association to provide \$32,000 to WLC to use for kids.

- Goal for fund-raising is to only have the Casino one every 18 months and the Trip Raffle
- Coupon books are available at the breakfast counter every morning
