Call to Order: Bob Burgess called the meeting to order at 8pm

Motion entered by Stephanie Williams to adopt September 2016's minutes. Seconded by Lisa Perich

- 1. Principal's Report Corey Sadlemyer
  - a. Picture retake day is October 20th, 2016
  - b. WE Day later in October. We have 21 students attending this year.
  - c. Halloween is on Monday October 31st this year.
  - d. Looking forward:
    - i. Report cards go home November 14th
    - ii. Student Led Conferences run November 16 & 17
- 2. Vice Principal's Report Troy Bartman
  - a. Looking for Parent Council support for the project with Editing Luke
  - Last year the school received an anonymous \$20,000 donation with the stipulation it goes towards the art. It was put towards hiring an Artist in Residence; Editing Luke
    - Luke documented life in our school for one year and now has enough footage to produce several episodes
  - c. \$8-10,000 is required to complete the project
    - i. We have applied to SD76 for a \$10,000 grant but they require a good show of faith that Parent Council is on board
    - ii. Requesting \$1000 from Parent Council
  - d. Motion entered by Lisa Perich to contribute \$1000 from PC towards the project
    - i. Seconded by Stephanie Williams
    - ii. All in Favour Motion Passed

- c. Focus is on settling into routines and building relationships with the students
  - i. There is a big focus on making them feel connected and comfortable

- e. The teachers are looking to do cross curricular projects this year that include parts from both STEM (Science Technology Engineering & Mathematics) and Humanities (Social Studies & Language Arts)

  - Raffle Trust account is now full, so remaining tickets sold, the money will go into the Raffle Proceeds account

    - i. Seconded by Stephanie Williams
    - ii. All in Favour Motion Passed
- 5. Committee Reports
  - a. Hot Lunch Lisa Perich
    - i. Trying out new ways to speed up the lines when serving hot lunch
      - 1. Currently pre-packing kindergarten to grade 2 and delivering to classrooms
    - ii. Online orders are working amazing now!!! Make it much easier for us as there is less to count.
  - b. Fundraising Stephanie Williams
    - AdMazing Coupon books and Magazine sales are way down when compared to last year
    - ii. The raffle is at the point of no return now. We need to really push the remaining ticket sales!!
      - 1. All tickets sold from now until the end are 100% pure profit for the school.
  - c. Special Events Stephanie, Lisa & Alexis
    - Need to hold a meeting in November to start planning Winter Wonderland
    - Need to also hold a meeting in November to begin planning year end activities for grade 9's
  - d. Playground Alexis Routly

- i. Waiting on delivery. It's been approximately 3 weeks since we sent in the first cheque so delivery should be hopefully happening in the next 2-5 weeks.
- ii. Troy Bartman
  - 1. We have been receiving fast answers to any questions we send their way via email.
  - 2. The project manager we were dealing with has left the company for a job with the Edmonton Oilers.
    - a. President of the company assured us that everything will continue as planned.
  - 3. They are a new company and not everything has been as clear as it was when we were dealing with Blue Imp on the previous playground.
    - a. Still waiting on a list of tools required for the install for instance.
  - 4. SD76 has said they will pay for the site prep
  - 5. Troy's brother will help to manage the land prep
- iii. Alexis
  - 1. Concrete is still said to be donated. Will follow up to ensure they are still on board.
- iv. Steph has been working on another grant with Corey to help cover the cost of the pour in place (rubber) surface
- v. PC needs to start recruiting volunteers for the playground install (preference given to people in the trades or experience in this type of install)
  - 1. We need tentative dates to give the volunteers.
- e. Parent Council Etc.
  - i. School needs new microwaves as 2 are broken
  - ii. Bob found a deal to get them for approximately \$99 (before taxes)
  - iii. Motion to spend up to \$600 on up to 5 microwaves entered by Stephanie Williams
    - 1. Seconded by Alexis Routly
    - 2. All in Favour Motion Passed
- f. Community Association
  - i. We need liability insurance in order to sell tickets at the Market at Medalta
    - 1. SD76 provided us with an option for insurance but they lumped together PC, CA, construction, theft & Director's insurance all in one

- a. Premiums were outrageously high do the amount of income brought in on a yearly basis by PC & CA
- Bob Burgess inquired with his own insurance company to see if we could acquire cheaper liability for just markets and one time insurance for accidents during the playground install
  - a. Liability Insurance to cover us at the market (\$2million liability) was \$70/30 day period or \$325/year
  - b. Looking into Director's Liability
  - c. Looking into one time construction insurance to cover us and our volunteers during the playground install
- Bob also spoke with a contact at SD76 that reassured us that events and activities at the school with staff supervising (like hot lunch for instance) are covered under the school's blanket insurance
- 4. Motion to spend up to \$500 on liability insurance entered by Stephanie Williams
  - a. Seconded by Lisa Perich
  - b. All in Favour Motion Passed
- 5. Bob will follow up with insurance
- 6. Wilson Wear Troy Bartman
  - a. We will be sending home a note with students to raise awareness of the Wilson Wear (clothing)
  - b. The products seen so far are great quality
  - c. \$634 has been spent on clothes so far by various people online
  - d. Stephanie suggested we move the link on the Roy Wilson website to a more prominent position (it's currently way at the bottom and easily scrolled past).
